If you or your child has prior injuries you must let me know so I can plan your activities accordingly. This will help to heal and prevent further injury.

No Food Allowed during class or on the dance floor. Snacks may be eaten between classes.

All cell phones must be turned off during class time.

All students must arrive promptly for class. If the student arrives 15 minutes late to prevent injury he/she will be asked to observe class for the day. Any missed classes may be made up with in one week of the missed class.

NO SMOKING in or around the dance studio. This means outside as well.

NEBT will be recording all performances and some rehearsals for documenting and advertising purposes. Everyone who is a member of the studio at time of distribution will be able to purchase a copy.

Class schedules, rehearsals, and performance dates are subject to change. Please check the board when dropping off your child for any changes.

Missing more than 3 rehearsals will result in being pulled from the upcoming show.

Due to sickness/commitments substitute teachers will be hired.

Snow days will coincide with the Falmouth and Mashpee school system. NO FALMOUTH/MASHPEE SCHOOL = NO DANCE

Proper attire is mandatory for all class/performance/rehearsals. Please make sure you have extra tights, leotards, hair pins, and your dance shoes in your bags at all times. NO BUN = NO DANCE, NO EXCEPTIONS
